Maintains high level of customer service by developing and maintaining direct communication with customers and creating loan programs to meet customer needs. Develops organization strategy in concert with essential partners and board. Actively participates in reviewing and structuring approximately five to ten bond issues per year, both private placements and public offerings, for a variety of non-profit health care providers throughout Washington State. Actively solicits health care providers' needs and requirements in obtaining capital financing. Oversees staff operations, and essential partners (general counsel, bond counsel and financial advisor).
