

Background: The 2024 elections will mean a lot of change for Washington State’s legislature. Below is a table of information explaining some of these changes prior to the primary election in August 2024. Some state legislators are retiring, some Representatives are now running for the Senate and others are running for statewide office. Another major change for some districts in Washington State is a recent court ruling changing the legislative district maps and moving some hospitals into new districts. Please review the table below to understand if your hospital has been impacted.
