The proposed changes update and modernize WAC 246-310-290. The revisions more clearly describe and clarify the methodology used for projecting future need for hospice services. These projections are used in the CoN hospice services application review process. The proposed changes establish consistent, timely and efficient decision making by the department, and will result in increased patient access to affordable, quality health care, consistent with the intent of chapter 70.38 RCW. The supplemental proposal makes substantive changes to the original proposal by retaining the average daily census (ADC) of thirty-five rather than twenty-five as previously proposed. During the 2017-2018 legislative session, the legislature passed ESSB 6032, which provides an enhanced provider payment for pediatric evaluation and management codes and vaccine administration codes. The enhanced rate is intended to maximize access to pediatric primary care services for children through eighteen years of age who receive medical assistance services via fee-for-service (FFS) and managed care.
